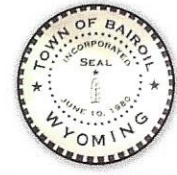

Minutes
Regular Council Meeting
Wednesday July 15, 2020 at 7:00 p.m.

Mayor Sue Ann Rigano called this meeting to order at 7:04 p.m.
Council Members present were Mayor Pro-Tem Lowell Clawson, Gust Hatanelas, Dana Clawson and Debra Morgan.
Others present were Attorney Mike Roberts and Clerk Ashely Jones.

The Pledge of Allegiance was recited.

Public Comment: There was none.

Approval of the minutes for July 1, 2020 as they were posted according to law. With no changes necessary the minutes stand as written.

A motion was made by Gust Hatanelas and seconded by Dana Clawson to approve the amended agenda of July 15, 2020. Motion passed. Add to old business- BLM.

Monthly Reports:

Police: There was none.

Court: There was no court held on July 1, 2020, no citations were issued. The next scheduled court date is August 5, 2020.

Water/Sewer: The water level in the tank is at 33 feet, the level was holding at 38.5 until there was a water leak at the CO2 plant. Battle Springs had not been turned on as of yet, however by the first part of August we will probably turn it on. The chlorine level is at 0.4. **There are several people watering their lawns for several days at a time and could be a problem in the near future.** The sewer lagoons are normal for this time of year with no visible problems. The Town will purchase bio bug treatments to keep the sludge down as per the usual annual treatment plan.

Maintenance: Mowing and brush hogging has been done at trencher park, school, road sides, fire hall, water tank and burn pit. The park sprinkler system is now running as it should, there were two small leaks in the supply line that have been repaired. The Town is still waiting on a plumber to get the parts in that are needed to fix the park bathrooms and a new lock has been ordered for the council room door.

Fire: There was none.

Mayor's Report: The Town emailed a previous applicant for the Police Officer position and he was still interested. An interview will be set up for him to come here the first part of August.

There was a water leak at the CO2 Plant that has been found and repaired. Battle Springs has been repaired, now the Town may use it if needed with notification to Amplify first.

Old Business: A motion was made by Debra Morgan and seconded by Gust Hatanelas to table the business license until Attorney Mike Roberts could do some research on the matter. Motion passed.

The council still has some concerns and questions before they move forward with the possible purchase of the shooting range. Clerk Ashley Hopkin will contact John Elliot and see if he will come to a council meeting to answer any questions the Mayor and council have.

New Business: Gust Hatanelas made a motion and was seconded by Debra Morgan to refund Plus Electric for the camper lots 102, 104 and 106 Indian Paintbrush. His deposit was \$150.00 for each camper and after electric was taken out the total he will be getting back is \$142.00 for 102, \$142.20 for 104 and \$142.00 for 106 Indian Paintbrush. Motion passed. Lowell Clawson abstained due to pecuniary interest.

No executive session was needed.

A motion was made by Lowell Clawson and seconded by Gust Hatanelas to pay Check# 14411 through Check#14448 including all EFT's and debit card charges. Excluding Check# 14423, 14424, 14425 and 14426. Motion passed.

A motion was made by Lowell Clawson and seconded by Debra Morgan to pay Check#14423 to Dana Clawson. Motion passed. Dana Clawson abstained due to pecuniary interest. A motion was made by Lowell Clawson and seconded by Debra Morgan to pay Check# 14425 to Gust Hatanelas. Motion passed. Gust Hatanelas abstained due to pecuniary interest. A motion was made by Lowell Clawson and seconded by Dana Clawson to pay Check# 14426 to Debra Morgan. Motion passed. Debra Morgan abstained due to pecuniary interest.

Debra Morgan made a motion and was seconded by Gust Hatanelas to pay Check# 14424 to Lowell Clawson. Motion passed. Lowell Clawson abstained due to pecuniary interest for a total amount in bills \$25,542.64.

With no further business this council meeting was adjourned at 7:37 p.m.
