Minutes
Regular Council Meeting
Wednesday October 7, 2020 at 7:00 p.m.

Mayor Sue Ann Rigano called this meeting to order at 7:03 p.m.
Council Members present were Mayor Pro-Tem Lowell Clawson, Dana Clawson and Gust Hatanelas and Debra Morgan.
Others present were Clerk Ashley Hopkin.

The Pledge of Allegiance was recited.

Public Comment: There was none.

Approval of the minutes for September 16, 2020 as they were posted according to law. With no changes necessary the minutes stand as written.

A motion was made by Debra Morgan and seconded by Gust Hatanelas to approve the agenda for October 7, 2020. Motion passed.

Mayor's Report: The leak at 410 Indian Paintbrush has been completed, there were two holes in the line.

Tim from Care More (out of Rawlins) came today and winterized the park sprinkler system so that is done and ready for winter.

Jean Guy who is a medical massage therapist, physical therapist and also does dry needling came out to look at the Healthcare Clinic on Saturday October 3, 2020. She would like to start coming out two days a month and start on Saturday October 24, 2020.

Old Business: A motion was made by Gust Hatanelas and seconded by Lowell Clawson to take off the table the outdoor sign. The Council all agreed to purchase the sign. Motion passed.

Dana Clawson made a motion and was seconded by Gust Hatanelas to ratify Mayor Rigano signing of paperwork to purchase the outdoor sign. Motion passed.

New Business: Debra Morgan made a motion and was seconded Gust Hatanelas to go into executive session at 7:11 p.m. Motion passed. Council came back into regular session at 7:22 p.m. Mayor Rigano asked the council if there was any objection to anything that was discussed in executive session. There was no objection.

A motion was made by Lowell Clawson and seconded by Gust Hatanelas to pay Check# 14533 through Check# 14575 including all debit card charges and EFT's excluding Check# 14534, 14535, 14536 and 14537. Motion passed.

A motion was made by Lowell Clawson and seconded by Gust Hatanelas to pay Check# 14537 to Dana Clawson. Motion passed. Dana Clawson abstained due to pecuniary interest.

Lowell Clawson made a motion and was seconded by Gust Hatanelas to pay Check# 14536 to Debra Morgan. Motion passed. Debra Morgan abstained due to pecuniary interest.

A motion as made by Lowell Clawson and seconded by Debra Morgan to pay Check# 14535 to Gust Hatanelas. Motion passed. Gust Hatanelas abstained due to pecuniary interest.

Debra Morgan made a motion and was seconded by Dana Clawson to pay Check#14534 to Lowell Clawson. Motion passed. Lowell Clawson abstained due to pecuniary interest. Total amount in bills \$30,881.85.

With no further business this council meeting was adjourned at 7:25 p.m.
