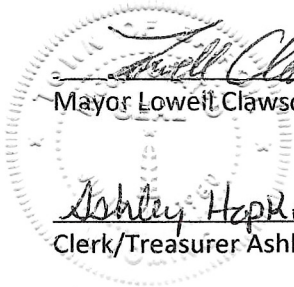
No executive session was needed.

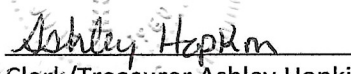
17325. Motion passed and Lowell Clawson abstained due to pecuniary interest. There was check#17330 in there for him.
